ThriveWell Cancer Foundation funded four cutting-edge research grants during 2012. The title of the funded projects are as follows: Targeting Survivin to Improve Therapy of Renal Cell Carcinoma; The San Antonio 1000 Cancer Genome Project; Improving the Efficacy of Chemotherapy Drugs for the Treatment of Triple Negative Breast Cancer; and Whole Genome Study to Understand the Mechanism Behind Exercise-Driven Attenuation of Breast Cancer.

4b (Code:) (Expenses \$ 121,396. including grants of \$) (Revenue \$)

Deriving Inspiration & Vitality Program (DIVA) provides exercise, nutrition and wellness classes to breast cancer patients and survivors in San Antonio and Bexar County. Research shows that women who exercise and follow a low-fat diet and adhere to their recommended hormonal or chemotherapy, have a reduction in breast cancer mortality by up to 50%. In 2012, more than 577 breast cancer patients and survivors participated in 4,717 classes at the four different DIVA locations in the area. Additionally, the DIVA program's Eat Well to Live Well nutrition eight-week series was provided eight times to 76 DIVA participants.

Thrivewell Cancer Foundation arranged for 1,688 free one-way rides to 44 patients needing transportation to and from chemo and radiation treatment. The financial assistance program assisted 132 patients helping offset the costs associated with their treatment.

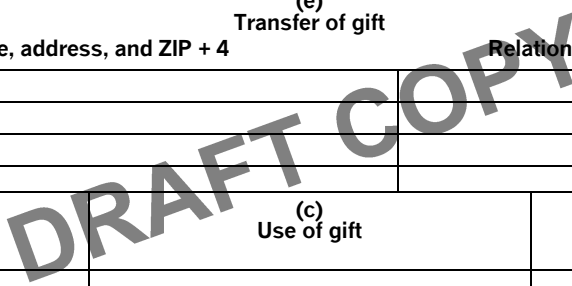
